DARLINGTON BOROUGH COUNCIL (PUBLIC BRIDLEWAY NO.10 IN THE PARISH OF HURWORTH) DIVERSION ORDER 2021

This Order is made by Darlington Borough Council ('the Council') under Section 257 of the Town and Country Planning Act 1990 ('the Act') because it is satisfied that it is necessary to divert part of Bridleway 10 in the Parish of Hurworth in order to enable development to be carried out in accordance with planning permission granted under Part III of the Act, namely Planning Application Reference 20/01221/FUL relating to the conversion of 2 no. two bed semi-detached dwellings to 1 no. five bed detached dwelling at Rockcliffe Cottages, Blind Lane, Hurworth, Darlington ('the Land').

BY THIS ORDER

- 1. The public bridleway over the Land shown by a hatched line on the attached map and described in Part 1 of the Schedule to this Order ('the Schedule') shall be stopped up after 14 days from the date of confirmation of this Order.
- 2. There shall, at the end 14 days from the date of confirmation of this Order, be a public bridleway over the Land shown by a purple line on the attached map and described in Part 2 of the Schedule.
- 3. Mr Francis Ward, c/o ELG Planning, Gateway House, 55 Coniscliffe Road, Darlington DL3 7EH is hereby required to carry out and pay for the works required in bringing the new bridleway into a fit condition for use by the public in consequence of the coming into force of this Order and any expenses which are incurred.
- 4. Where immediately before the date on which the bridleway is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.
